

## Weekly Market Review September 8, 2015

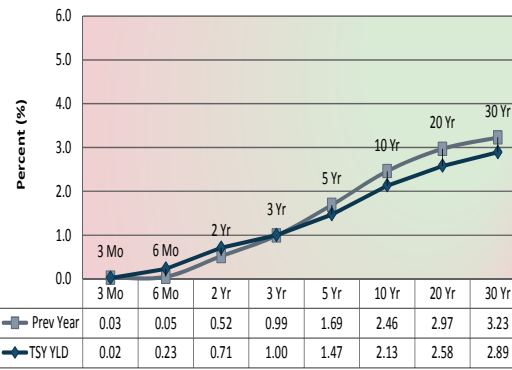
### News Headlines

- The refugee crisis in Europe has UN leader calling for a global response worldwide.
- Congress is back in session with many decisions expected this week including the Iran nuclear deal.

### Economic News

- The Shanghai Composite Index dropped 14% in July.
- Japan experienced a decline in industrial production in July, down 0.6%, after a 1.1% increase in June.
- U.S. consumer confidence fell to 91.9 in August failing to meet the expected forecast of 93.0.
- U.S. unemployment rate dropped to 5.1% in August, the lowest rate since 2008.
- U.S construction spending was up 0.7% in August, reaching its highest level in over seven years.

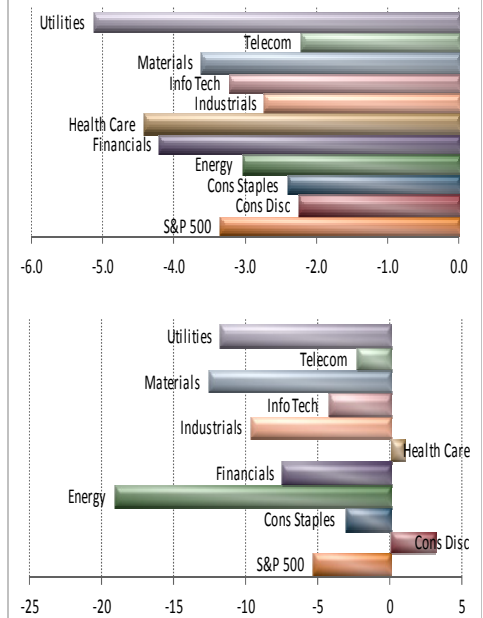
