

## Weekly Market Review September 21, 2015

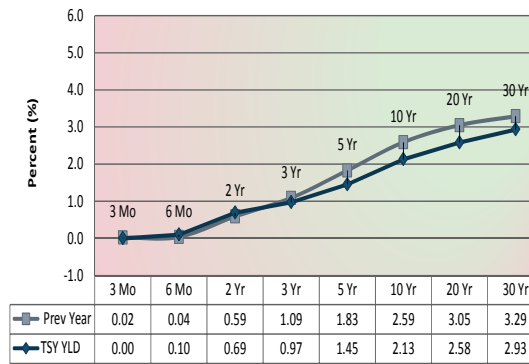
### News Headlines

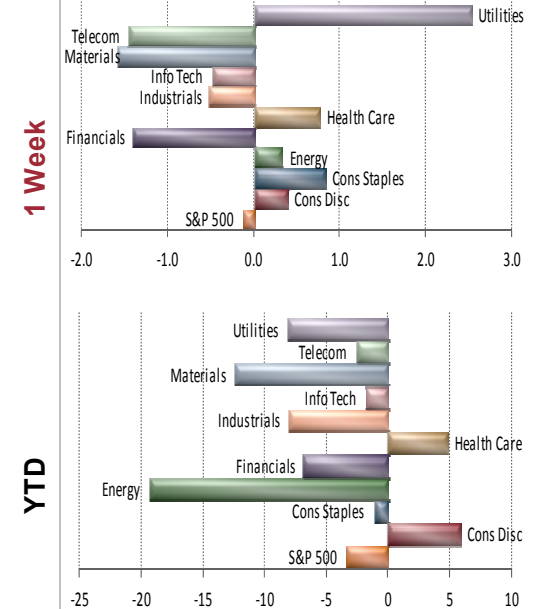
