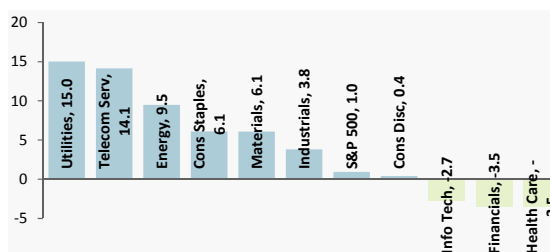
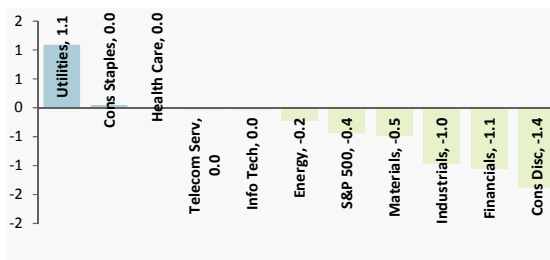

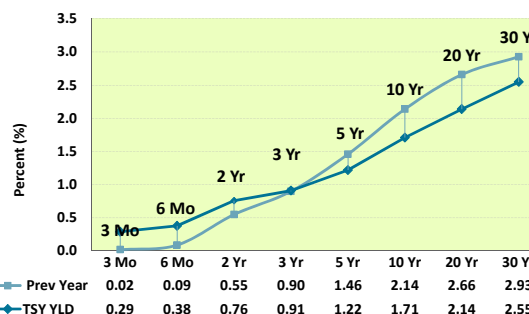
S&P 500 Sector Returns
