
- On presidential news, last week President Obama gave his farewell speech in Chicago and confirmation hearings for President-Elect Trump's cabinet began.

Economic News

- NFIB small business optimism index soared in December to 105.8, the highest level since December 2004.
- Exports from China fell 7.7% in 2016, marking a second year of decrease.
- Germany's economy grew 1.9% in 2016, the biggest growth in 5 years.
- The World Bank expects the global economy to expand 2.7% in 2017, buoyed by the expectation of fiscal stimulus in the US.
