- North Korea continues to cause worldwide concern as they carried out a nuclear test on Sunday. The U.N. held an emergency meeting yesterday to consider ramifications for this latest provocation.
- An estimated 60 people have died as a result of Hurricane Harvey. Storm damage has been estimated as high as \$180B by Texas Governor Greg Abbott.
- Hurricane Irma continues to make its way towards the U.S. coast. Irma is now a category 5 hurricane and concerns are growing over the path of the storm and its potential to make landfall.

- United Technologies has reached a deal to buy Rockwell Collins for \$23B, the biggest-ever aerospace deal.
- Q2 GDP was revised up from 2.6% to a 3%.
- The U.S. Labor Department reported that the unemployment rate rose to 4.4%.
- Consumer confidence rose to an impressive 122.9, the 2nd highest result since December 2000.

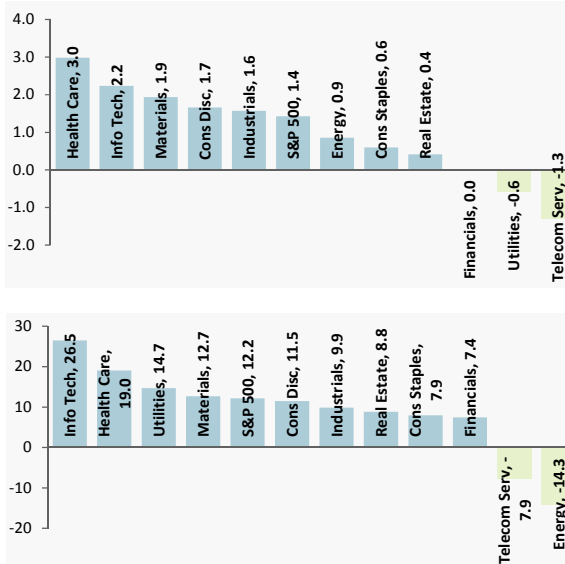

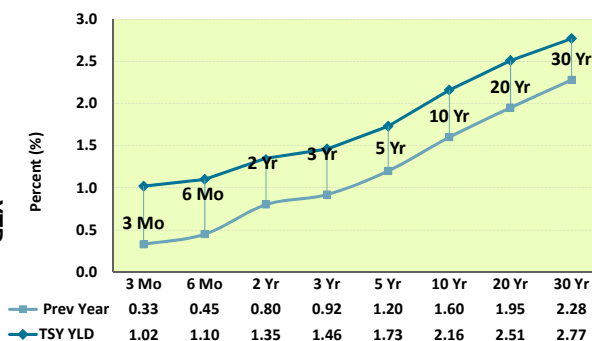
