- A new trade accord was announced on Sunday between the U.S., Mexico and Canada which will replace NAFTA.
- A deadly 7.5 magnitude earthquake triggered a tsunami last week in Indonesia killing over 800 people and displacing thousands. One of the hardest-hit areas is in the island of Sulawesi in the city of Palu.

## Economic News

- The Federal Reserve announced Wednesday it would raise the Fed interest rate by 25 basis points, to a range of 2.00% to 2.25%, marking the 3rd rate hike of the year.
- The U.S. Bureau of Economic Analysis released the 3rd estimate for GDP Q2 confirming that the annual rate increased 4.2%.
- The University of Michigan revised the U.S. consumer sentiment downward for September 2018 from 100.8 to 100.1.

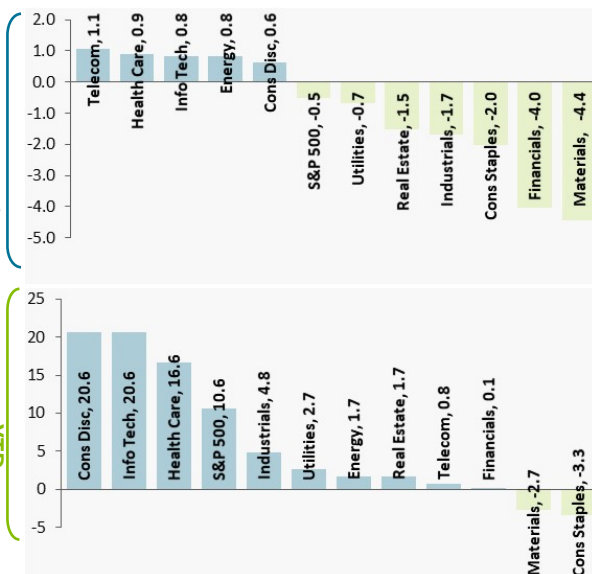
