



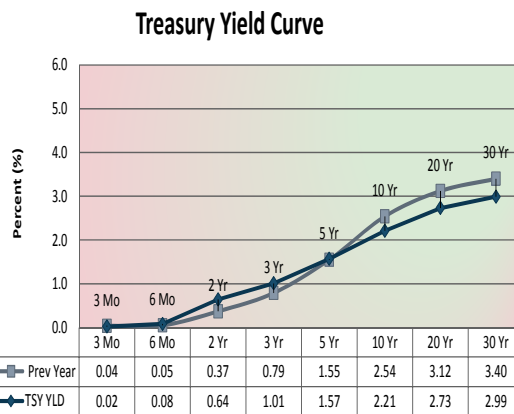
## Weekly Market Review May 26, 2015

### News Headlines

- Deadly storms in the west kill 5 with 12 still missing due to severe flooding.
- The Senate voted 62-38 to approve a measure that would give the President authority to seek ratification of a 12-country Pacific trade deal without congressional amendment.

### Economic News

- Japan was the largest creditor nation for the 24th consecutive year in 2014, with net external assets reaching \$3Tn, 1.7x the amount in China.
- Japan slipped back to trade deficit in April, after making its first trade surplus in more than two years the month before.
- US crude-oil supplies continued to fall last week, the third-straight week of declines.
- Housing starts climbed 20% in April.

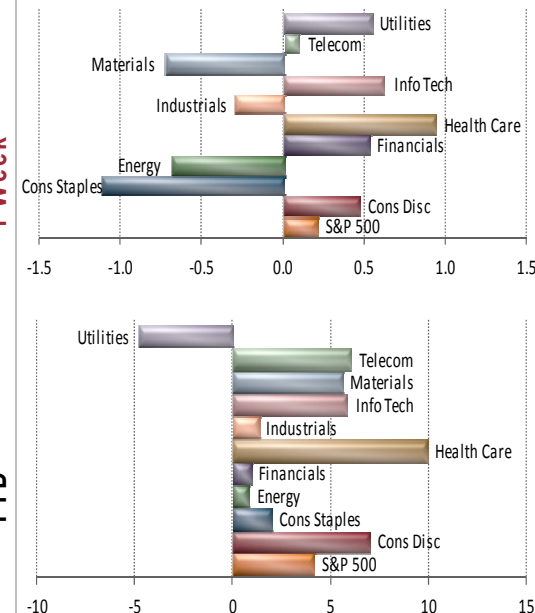
