



## Weekly Market Review June 15, 2015

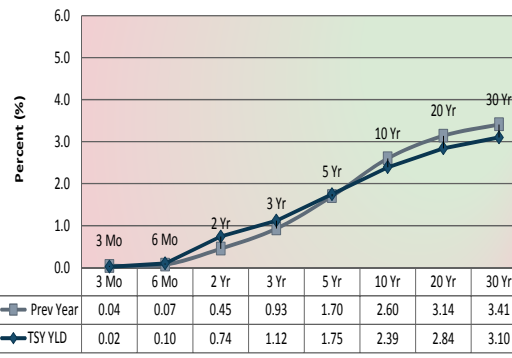
### News Headlines

- Italy continues to be overwhelmed by immigrants and looks to EU for help in managing crisis.
- 2 convicted murderers are still on the run after escaping from a maximum security prison in New York nine days ago.

### Economic News

- Greek debt crisis continues with fear of default a reality as weekend talks end without progress with lenders.
- US wholesale prices jumped 0.5% in May, the biggest increase in nearly 3 years.
- US industrial production unexpectedly declined in May, a sign that weak global demand and the strong dollar are continuing to hold back output.
- Consumer sentiment rose in June to 94.6 after hitting a six-month low of 90.7 in May.

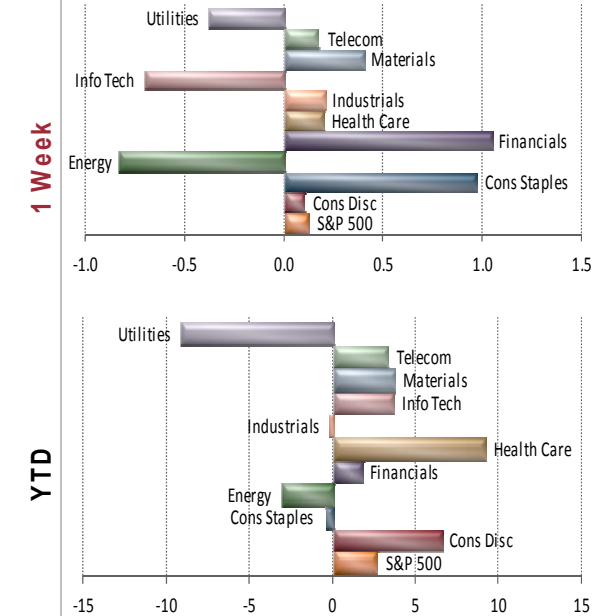
