



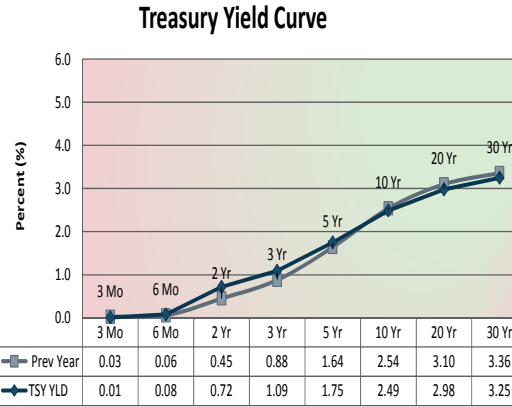
Weekly Market Review June 29, 2015

News Headlines

- The second escaped inmate from NY prison was shot and captured yesterday within a few miles of the Canadian border after being on the run for 22 days. The first inmate was shot and killed by authorities on Friday.
- U.S. Women advance to World Cup Soccer semi-final and play Germany on Tuesday in Montreal.

Economic News

- The Greek government has imposed capital controls, including closure of banks and the stock market effective Monday, after ECB refused to increase emergency liquidity.
- The US service sector posted slower growth in June for the third consecutive month.
- Consumer spending jumped to a near six-year high in May.
- Weekly jobless claims edged up by 3,000 to 271,000.

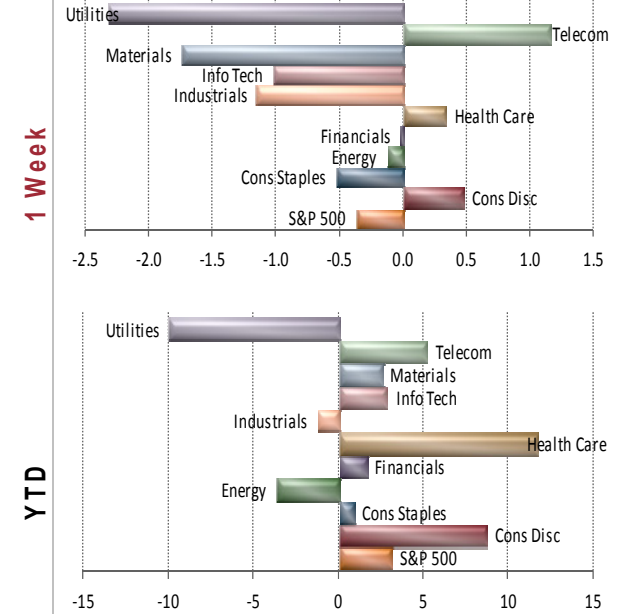
