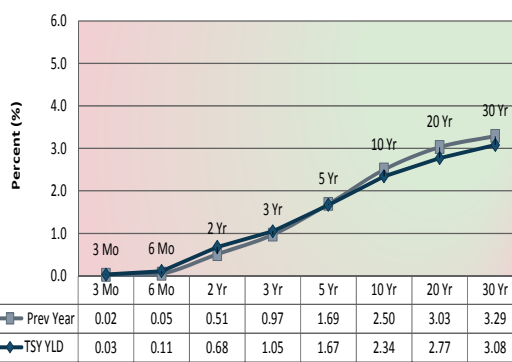
News Headlines

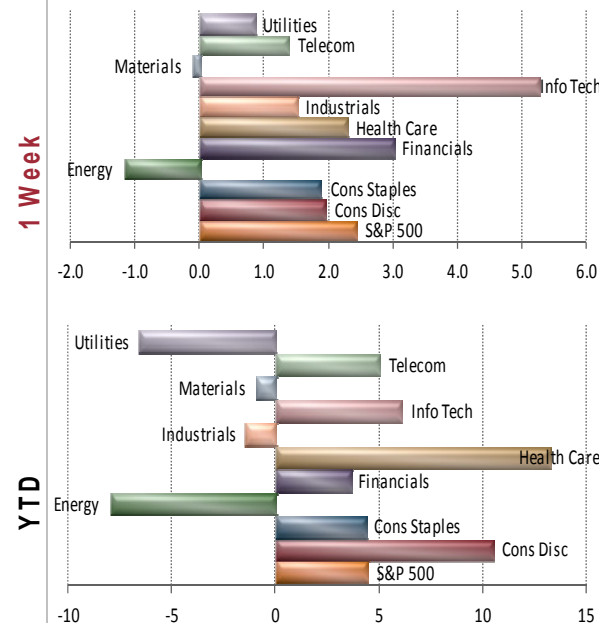
