

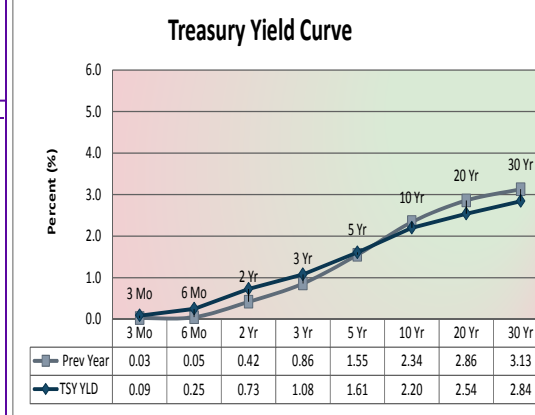
Weekly Market Review August 17, 2015

News Headlines

- The American Embassy in Cuba raised the American Flag for the first time since 1961.
- The Eurozone's Finance Ministers approved a \$96Bn new bailout loan for Greece. The deal marks an end to more than six months of stormy negotiations between the Greek government, EU and IMF.

Economic News

- US industrial output rose 0.6% in July.
- Personal spending rose 0.2% and personal income increased 0.4% in June.
- Consumer sentiment fell to 93.1 in July down from 96.1 in June.
- The Eurozone's economy grew a 1.3% in Q2.
- Japan's GDP shrank 1.6% in April-June quarter.

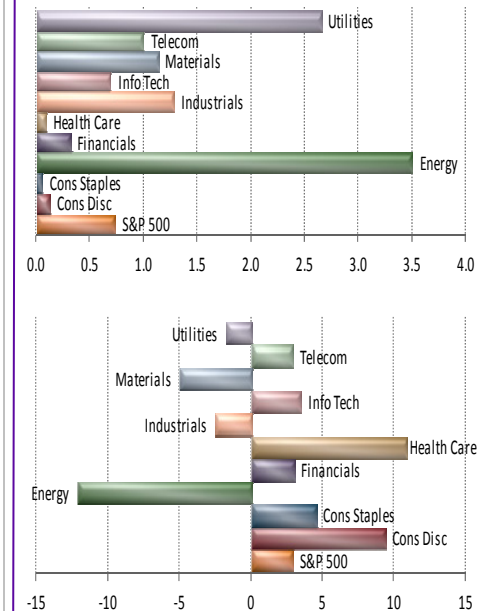
