

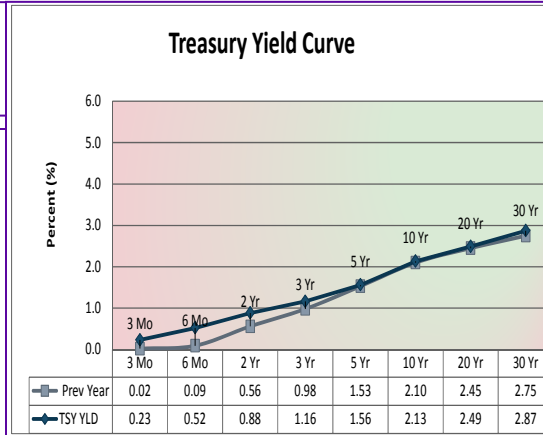
Weekly Market Review December 14, 2015

News Headlines

- A final agreement was reached at the global climate summit in Paris as nearly 200 nations agreed to voluntarily cut greenhouse gas emissions.
- Oil prices continue to fall amidst a supply glut as OPEC has been pumping at near record levels since last year in an attempt to undermine marginal producers.

Economic News

- The Federal Reserve is expected to raise short term interest rates when it meets later this week.
- Eurozone industrial output rose more than expected in October, a sign that economic output has picked up as the year draws to a close.
- Factory output in China grew at an annual rate of 6.2% in November beating expectations and up from October's rate of 5.6%.

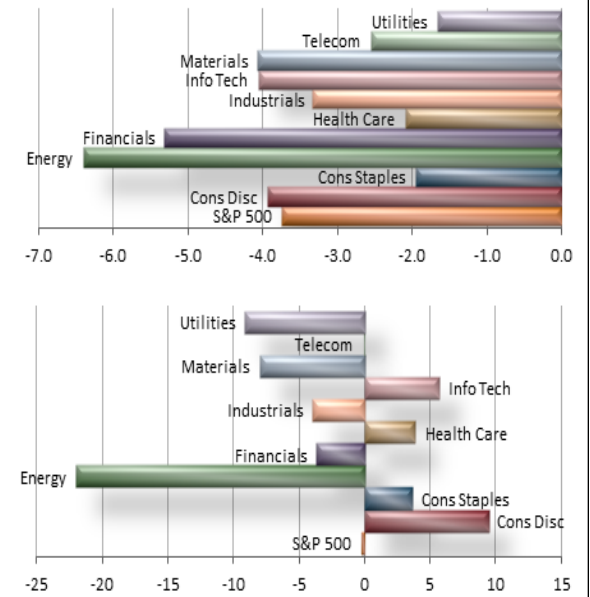
