

Weekly Market Review December 28, 2015

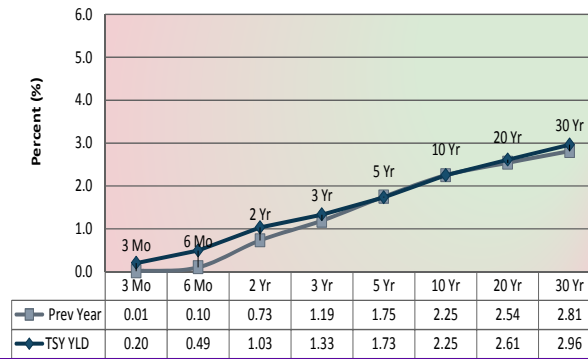
News Headlines

- At least 43 people were killed as violent storms swept through Texas and other parts of the US last week.
- Iraqi forces have retaken the city of Ramadi from the Islamic State. This marks a major turnaround for Iraq's military and deals the Islamic State its third major loss in as many months.
- "Star Wars - The Force Awakens" makes over \$1 Billion in 12 days.

Economic News

- Japan's Cabinet, under Prime Minister Shinzo Abe approves a record high 2016 budget of 96.72 trillion yen.
- Adjusted 2015Q3 GDP shows growth at 2%, down from 2.1% previously reported.
- The Commerce Department reported consumer spending and personal income increased 0.3% in Nov. and new homes sales rose 4.3% from Oct. to Nov.

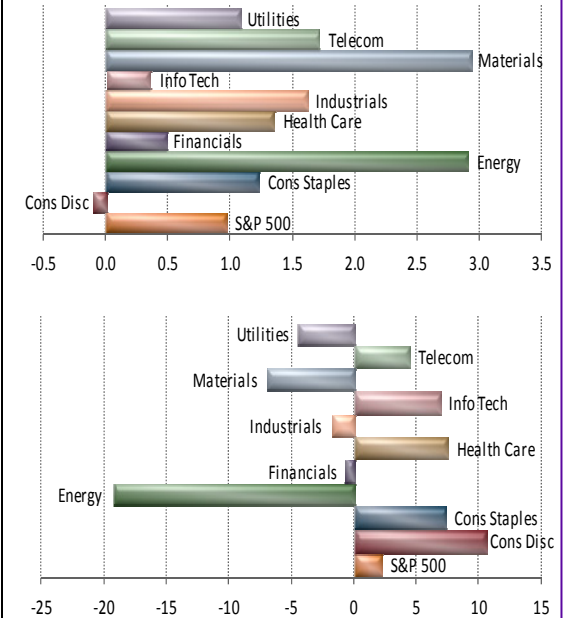
