- ISIS attacked a Baghdad market over the weekend killing 73 and injuring over 100.
- 3 people were killed by a gunman in a workplace shooting in Kansas last week. The shooter was killed during a gun battle with police.

Economic News

- Eurozone consumer prices rose 0.3% in January.
- First-time US unemployment applications increased by 10,000 to a seasonally adjusted 272,000 for the week ending February 20.
- The Consumer Confidence Index dropped to 92.2 in February, down from January's revised 97.8.
- New home sales dropped by a seasonally adjusted 9.2% in January marking the biggest decline in almost 6 years.
- The Association of Realtors reported existing home sales climbed 0.4% in January, and year-over-year sales rose 7.5%.



