- Hurricane Matthew has been downgraded to a tropical depression but has left a trail of devastation from Florida to the Carolinas. At least 19 people have died in the U.S. and 2 million remain without power.
- Parts of Haiti were completely destroyed by Matthew and the death toll has now risen above 900.

Economic News

- The U.S. unemployment rate edged up to 5%, even as employers added 156,000 jobs last month.
- The civilian labor force grew by 444,000 as more Americans came off the sideline seeking employment.
- German exports posted their biggest rise in 6 years, up 5.4%, allaying some fears that its economy is slowing down.

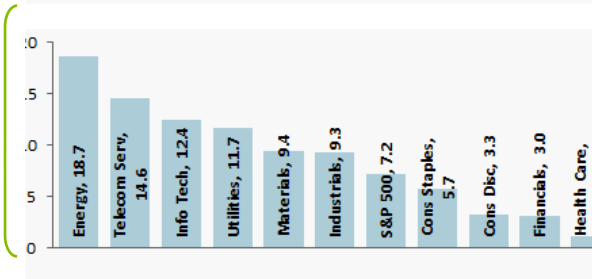
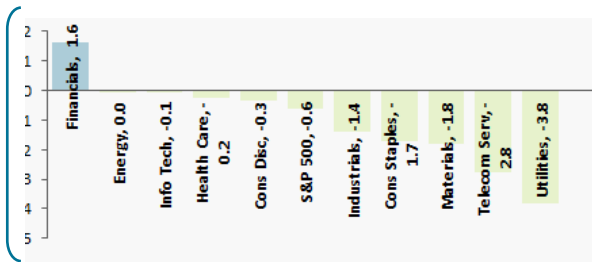

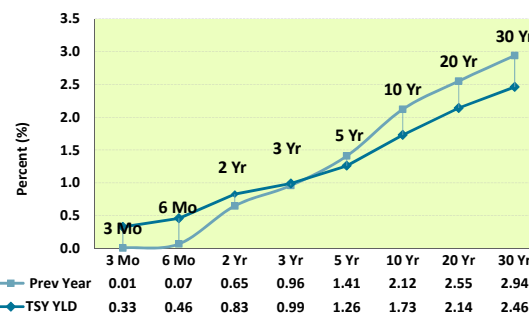
