- The U.S., France and Britain launched 105 missiles targeting three chemical weapons facilities in Syria in retaliation for the suspected poison gas attack in Douma on April 7.
- Deadly storms in the U.S. Midwest generated record snowfall and low temperatures on Sunday, leaving airline travelers stranded and thousands without power.

Economic News

- U.S. retail sales rose 0.6% in March to end a streak of three straight declines.
- Oil prices fell sharply and government bond yields rose today on expectations that this weekend's missile strikes in Syria would not mark the start of increased Western involvement in the conflict.
- The U.S. is planning to announce new economic sanctions on Russia aimed at companies it believes were dealing with equipment related to chemical weapons.

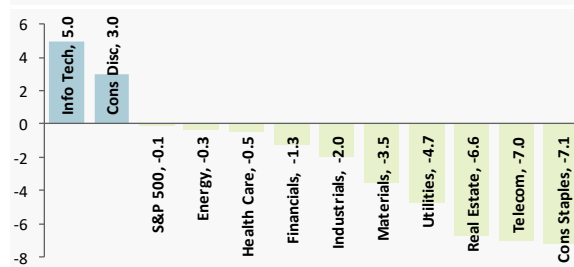
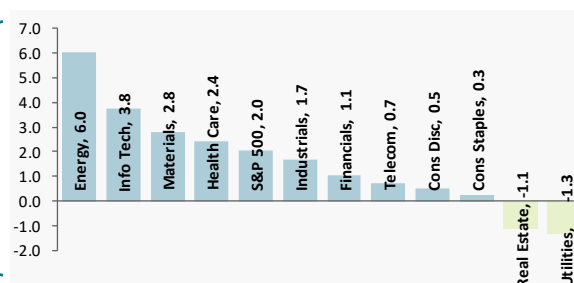

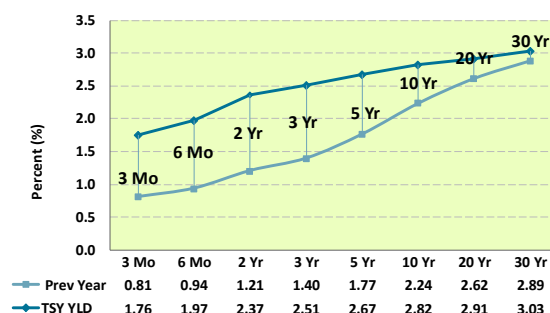
S&P 500 Sector Returns
