- The U.S. and China continued to clash on trade at the Asia-Pacific Economic Cooperation summit over the weekend resulting in the group's failure to agree on a joint communique for the first time in its history.
- Nissan plans to fire Chairman Carlos Ghosn over numerous financial misconduct allegations.
- Dangerous air quality continues to be a health concern for California residents recovering from recent wildfires. A total of 80 deaths have been confirmed with over 1,000 people still reported missing.

- Oil prices fell again last week, down another 6% from the previous Friday. Brent and WTI futures are down about 25% since early-October.
- The dollar steadied on Monday after falling near half a percent last week, its biggest weekly drop since late September.

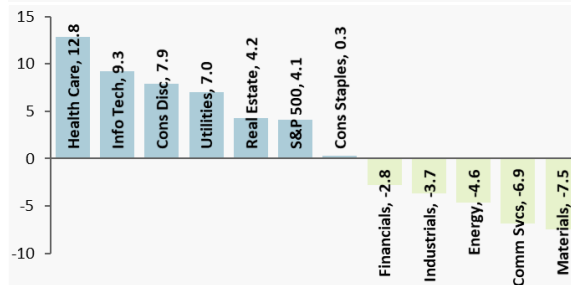
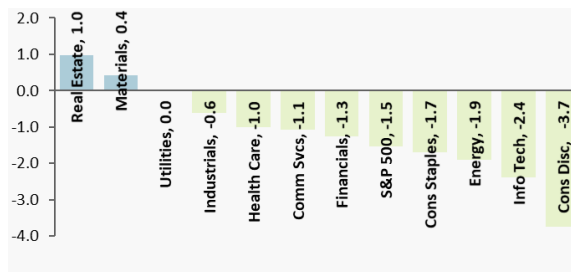

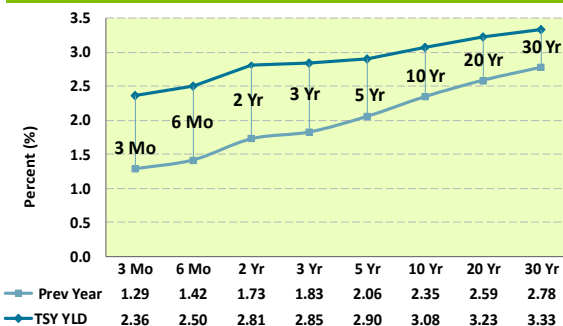
S&P 500 Sector Returns
