

**News Headlines**

- The impeachment inquiry of U.S. President Donald Trump continues this week as eight more witnesses are due to testify. The latest round of hearings will stretch from Tuesday to Thursday before the House of Representatives Intelligence Committee.
- Police are investigating a shooting in Fresno, California on Sunday where four people were killed at a backyard football game party. This follows another shooting on Thursday at a southern California high school where a 16-year-old boy killed two classmates and wounded three others before killing himself.

**Economic News**

- Consumer Prices (CPI) rose 0.4% in October, the largest jump in seven months. CPI is up 1.8% from one year ago.
- Producer Prices (PPI) also rose 0.4% in October, the largest jump in six months. PPI is up 1.1% from one year ago.
- Retail Sales rose 0.3% in October after September's surprise 0.3% dip. "Core" sales have been growing at a 7.8% annualized clip in 2019—the fastest 10-month rate of growth in almost 20 years.

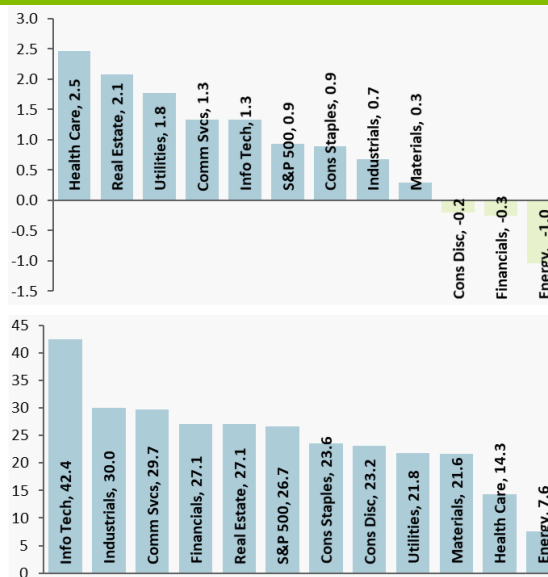

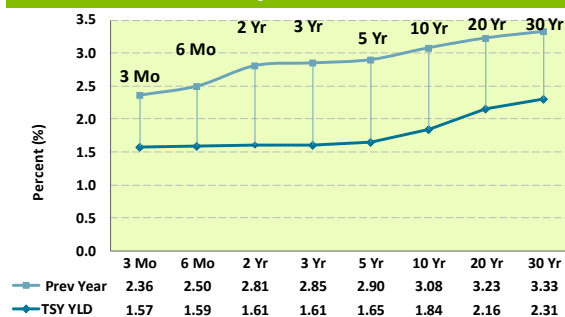
