- President Trump levied new economic sanctions against Iran after they launched retaliatory missile strikes against U.S. troops on multiple U.S. military bases in Iraq to avenge the death of Iran's Major General Qassem Soleimani.
- Protests erupted over the weekend in Iran after the government claimed that they mistakenly shot down the Ukrainian airliner last week killing 176 people after initially denying involvement with the crash.
- House Speaker Nancy Pelosi announced last Friday she will take action this week towards sending articles of impeachment against President Donald Trump to the Senate.

- Phase one of the U.S./China interim trade deal is scheduled to be signed on Wednesday at the White House.
- The U.S. Department of Labor announced on Friday that 145,000 new jobs were added in December 2019. The unemployment rate remained unchanged at 3.5% and average hourly earnings was up 2.9% year-over-year.

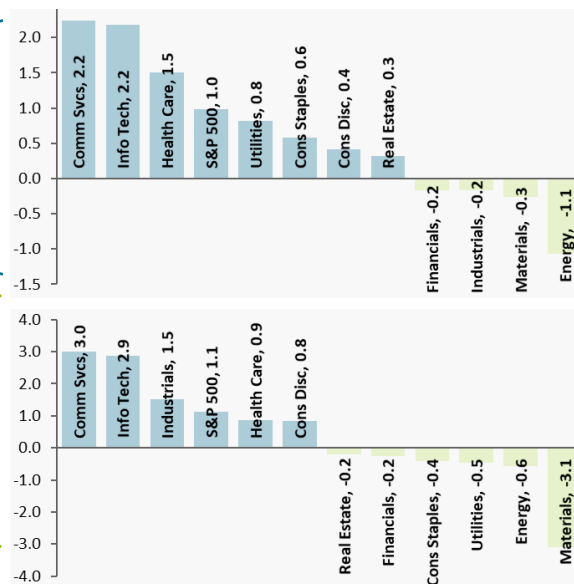

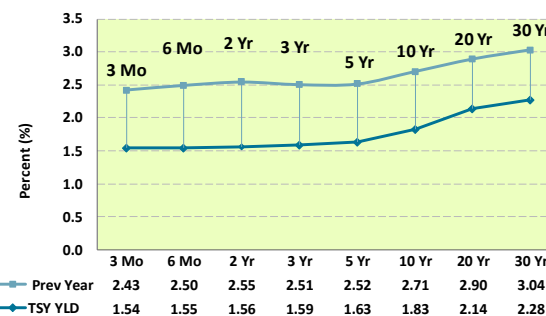
