- The U.S. Senate voted last Wednesday to acquit U.S. President Donald Trump on both articles of impeachment against him.
- The spread of the Coronavirus continues and 97 people died yesterday in China. The death toll in China is now over 900 and the estimated infected rate is now over 40,100.
- The Iowa Democratic caucus last week sparked controversy with difficulties in verifying the vote. The frontrunners that have emerged from Iowa appear to be Pete Buttigieg and Bernie Sanders.

Economic News

- The U.S. Department of Labor announced on Friday that 225,000 new jobs were added in January 2020. The unemployment rate rose slightly to 3.6% and average hourly earnings were up 3.1% year-over-year.
- The U.S. Bureau of Economic Analysis and the U.S. Census Bureau reported that the U.S. monthly international trade deficit rose 11.9% to \$48.9B in December 2019.

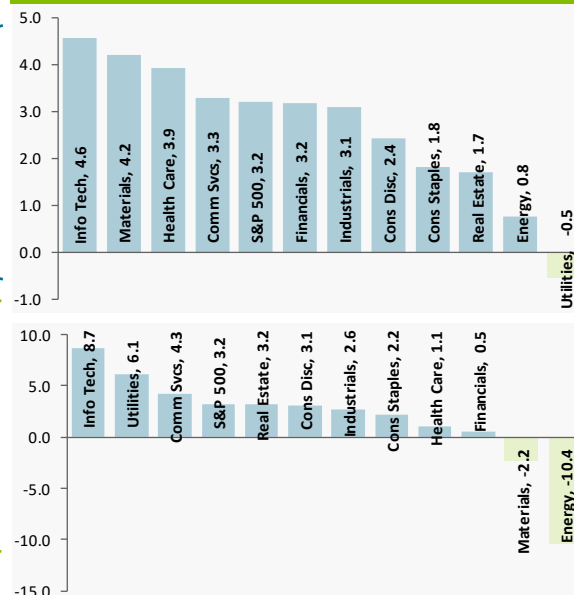

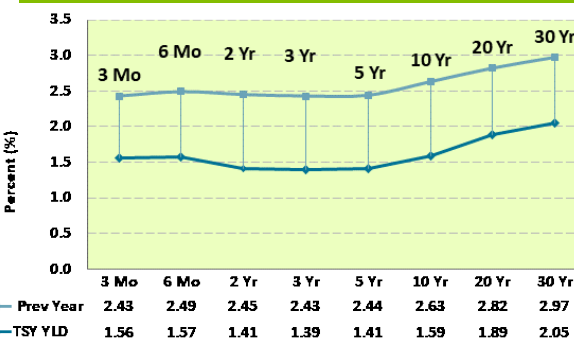
