

News Headlines

- Latest figures show over 4.12M confirmed cases of the coronavirus worldwide with almost 393,000 deaths. The U.S. currently has over 1.36M confirmed cases with almost 81,000 deaths, while CT is reporting 33,554 cases and 2,967 associated deaths.
- New Jersey's nursing homes have been hit especially hard by the coronavirus, claiming more than 4,850 lives accounting for half the state's Covid-19 deaths, which is well above the national rate.
- A friendly fire incident resulted in the death of 19 Iranian sailors as the Iranian navy conducted exercises in the Persian Gulf amid mounting tensions with the U.S.

Economic News

- The U.S saw the worst jobs report in history, losing 20.5M non-farm payrolls in April.
- The unemployment rate jumped to 14.7% which was less than the anticipated rate of 17% due to the fact that people have stopped looking for work; the labor participation rate fell by 6.4M in April.
- The U.S. services sector slid into contraction for the first time since 2009 as the ISM-nonmanufacturing index fell to 41.8 in April, down from 52.5 in March.

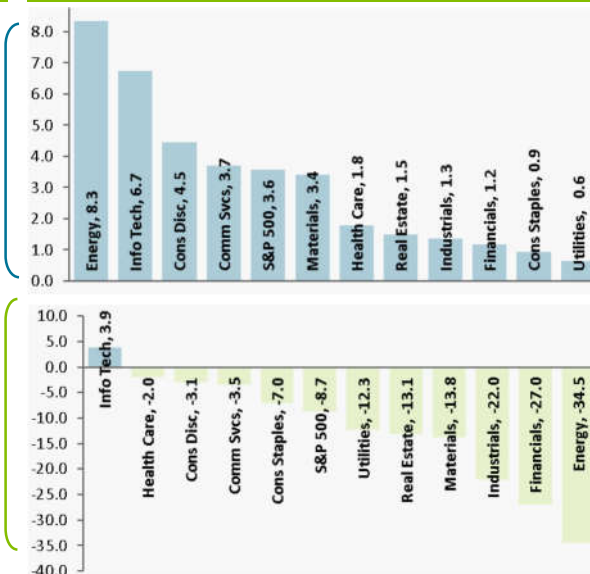
