

News Headlines

- Protests sparked by the police killing of George Floyd continued around the nation over the weekend as organizers vowed to continue rallying until they see concrete changes in police policy.
- Latest figures show over 7.0M confirmed cases of the coronavirus worldwide with over 403K deaths. The U.S. has over 1.9M confirmed cases with over 110K deaths, while CT has nearly 44K cases and 4,071 associated deaths.
- The May Employment report showed that non-farm payrolls rose 2.5M, shattering expectations of a 7.5M drop in new hires. The unemployment rate fell to 13.3% vs. consensus expectations of 19.0%.

Economic News

- Signs indicate that U.S. manufacturing has stabilized as the ISM Manufacturing Index rose to 43.1 in May, up from 41.5 in April.
- The ISM Non-Manufacturing Index was up as well in May, rising to 45.4 from April's 41.8.
- As lower paid workers returned to work, average hourly earnings declined by 1% in May, following April's increase of 4.7%.

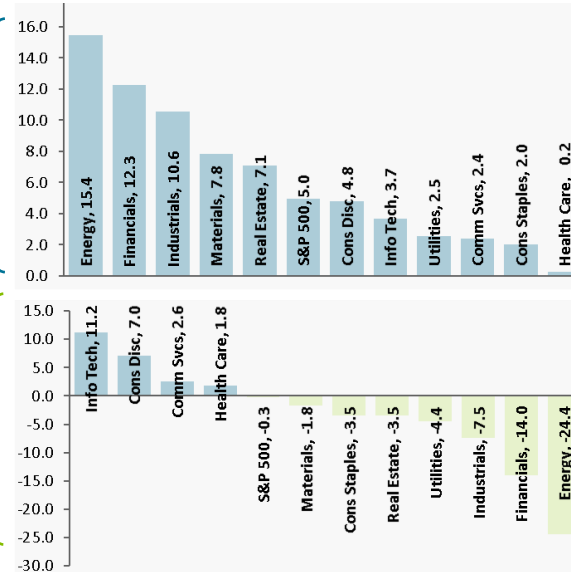

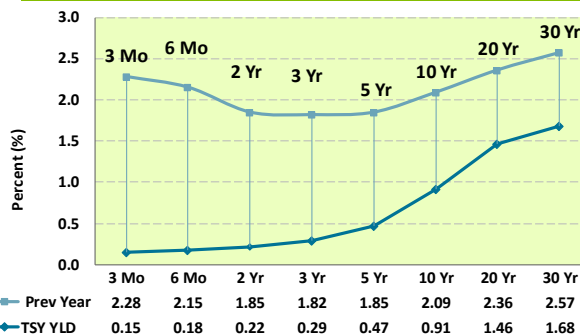
