

News Headlines

- Janet Yellen received Senate confirmation last week. She is the first woman to serve as the U.S. Treasury Secretary.
- Heavily shorted stocks have become the focus of retail investors and regulators after a short squeeze helped push GameStop Corp. stock up over 400% last week. The trading app Robinhood is receiving backlash on social media after disabling buy orders for GameStop during a period of extreme volatility last week.
- Former President Trump announced a new legal team ahead of impeachment hearings starting next week.
- A major winter storm is expected to hit the Northeast today through part of tomorrow packing blizzard conditions in some areas.

Economic News

- The advance estimate from the U.S. Bureau of Economic Analysis showed real GDP increased at the annual rate of 4.0% in Q4 2020. Despite the strong quarter, U.S. growth shrank 3.5% last year.
- New weekly jobless claims fell 26K last week to 847K.
- New Home Sales rose 1.6% last month and 2020 sales were up 18.7% from 2019.

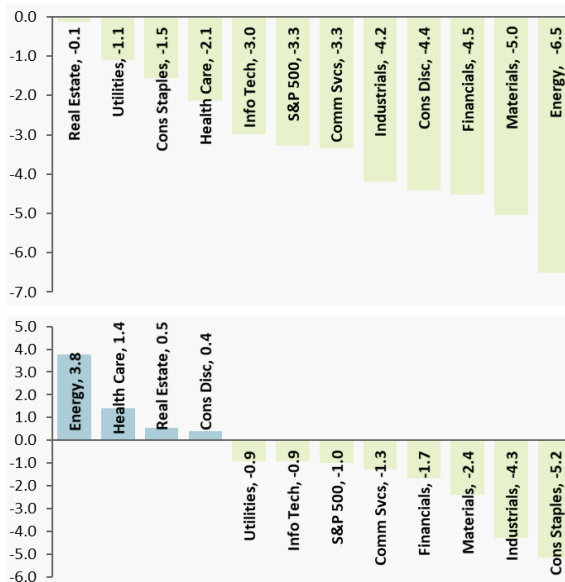
