

## News Headlines

- G-7 nations reached a historic deal on global tax reform last week to back a U.S. proposal that calls for corporations around the world to pay at least a 15% tax on earnings. Members of the G-7 will convene for a summit in Cornwall, U.K., this week.
- Amazon.com Inc founder Jeff Bezos announced he will fly to space next month on the first space flight from his rocket company, Blue Origin. The company is targeting July 20 for its first suborbital sightseeing trip.

## Economic News

- The U.S. economy added 559,000 non-farm payroll jobs last month—lower than the 675,000 consensus. Average hourly earnings rose 0.5% and are up 6.4% from February 2020. The unemployment rate fell to 5.8% from 6.1% in April.
- The ISM Non-Manufacturing Index hit 64.0 in May—its highest level on record, going back to 1977. The ISM Manufacturing Index rose to 61.2 in May.
- U.S. Car Sales fell 9.5% in May as parts supply issues lowered inventories which dampened sales.

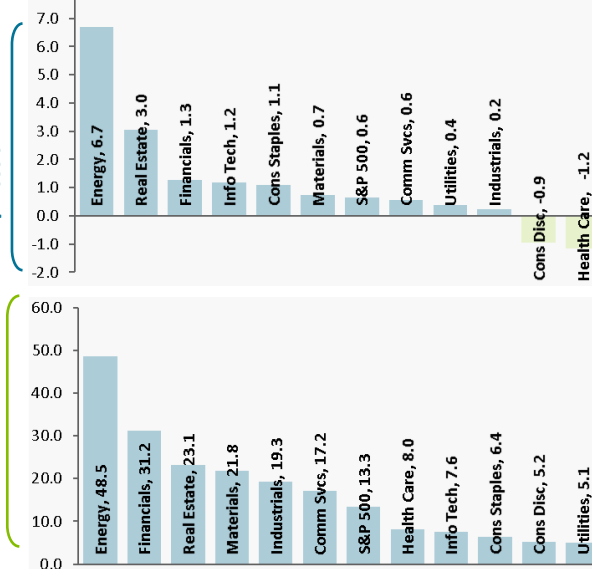

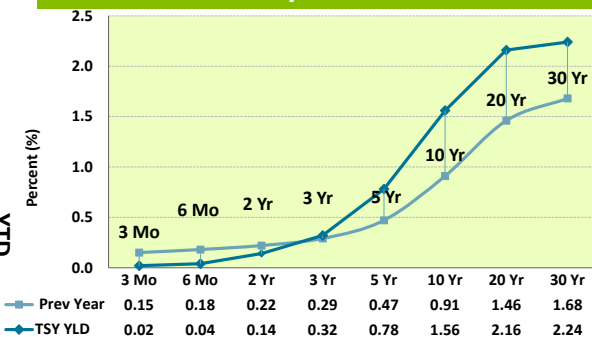
