

News Headlines

- The House passed President Biden's nearly \$2T domestic spending package along party lines. The package now faces an uncertain future in the Senate and will depend on support from moderate Democrats Manchin and Sinema.
- The number of U.S. Covid-19 related deaths so far this year has now surpassed the number that died in 2020 as total pandemic deaths now total over 770,800.
- At least 5 are dead and 40 injured after an SUV plowed through police barricades into the crowd at a Christmas parade in Waukesha WI on Sunday. One person of interest is in custody.

Economic News

- Retail sales rose 1.7% in October compared to September raising hopes among retailers that it will be a strong holiday season.
- U.S. industrial production increased 1.6% in October led by the auto sector which surged 11%, suggesting that supply chain issues may be resolving themselves.
- Initial jobless claims continue to decline, down slightly last week to 268k from the prior week's figure of 269k, while continuing claims fell to a pandemic low of just over 2 million.

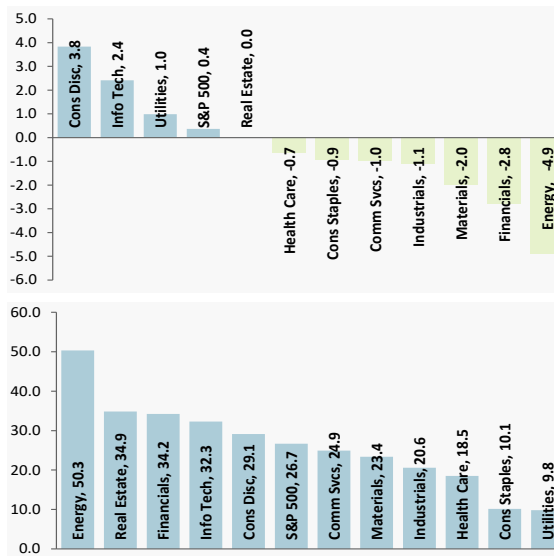

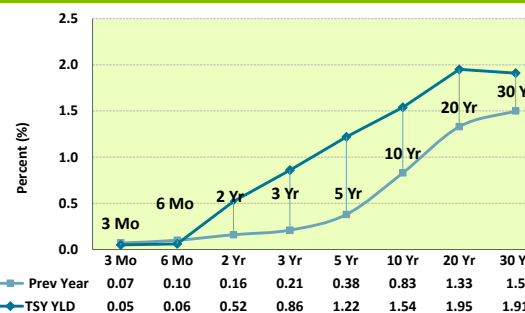
S&P 500 Sector Returns
