

Economic News

- Consumer Prices (CPI) rose 0.4% in February and are up 6% from one year ago. Core CPI, which excludes food and energy, rose 0.5% in February and is up 5.5% over the last year.
- Producer Prices (PPI) fell 0.1% in February, lower than estimates of a 0.3% increase. PPI has risen 4.6% over the past 12 months, down from 5.7% the previous month.
- Retail Sales fell 0.4% in February after jumping a revised 3.2% in January.
- U.S. Housing Starts rose by 9.8% in February, led by multifamily projects, but remain down 18.4% from one year ago. Permits rose 13.8% to 1.524 million after nearing a two-and-a-half-year low in January.

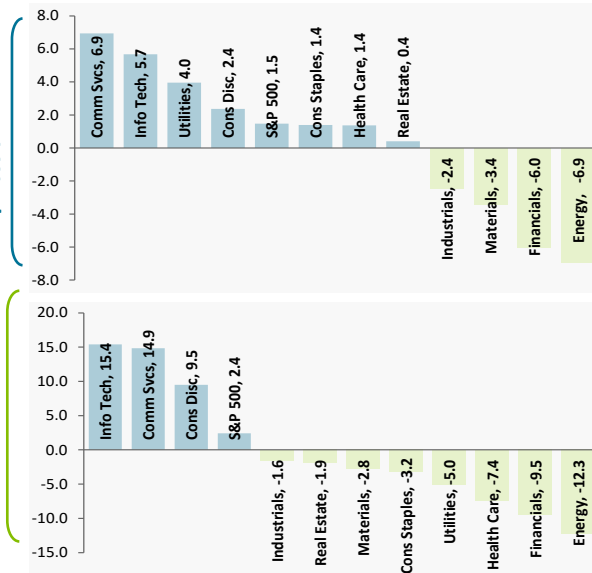

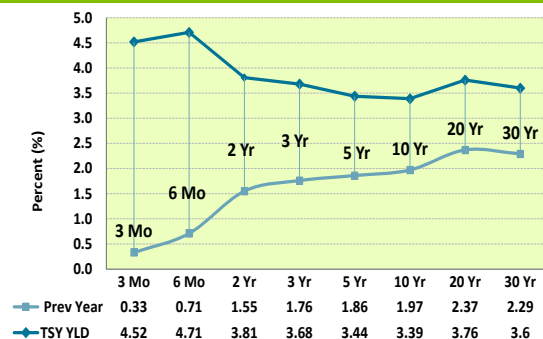
